Item No. 1: To confirm the minutes of the 12th Academic Council Meeting held on January 19, 2019

The draft minutes of the 12th meeting of the Academic Council held on January 19, 2019 were sent to the members of the Academic Council for their comments via e-mail. The same were tabled for confirmation.

Resolution: *Since, no comments were received, the minutes of the meeting was confirmed by the Academic Council.*

Item No. 2: Action Taken Report on the minutes of the 12th Academic Council Meeting held on January 19, 2019

The Item-wise Action Taken Report on the minutes of the 12th Academic Council Meeting was tabled before the Academic Council.

Resolution: *The members expressed their satisfaction, and resolved that the minutes were confirmed.*

Item No. 3: To approve the Structure and Syllabus of various courses in the Faculty of Engineering and Technology, Architecture, Pharmacy, Hotel Management and Catering Technology

3.1 The structure and detailed syllabus for following professional programs and academic calendar for the A Y 2019-20 was tabled for discussion:

1. The Faculty of Engineering & Technology.
2. The Faculty of Pharmacy.
3. The Faculty of Architecture.
4. Diploma programs at IoPE.

Resolution: *It was resolved to approve the same and suggested for uploading the same on University Website.*

3.2 Introduction of Auto Cad at first year and New Electives : It is proposed to introduce Auto Cad at first year and New Elective on Automotive Design in Mechanical Engineering Discipline in collaboration with Tata Technologies:

Resolution: *The proposal put up by the chairman BoS Mechanical Engineering was discussed and approved for the adoption of the same from Academic Year 2019-20. Subsequently, after due discussion, it was resolved to form a Committee consisting of the following to look into the issue of Replacing traditional Engineering Drawing subject with*

CAD/CAM based Engineering Drawing subject:

2. **Prof. M. Sadaiah** : **Mechanical Engineering**
3. **Prof. A.W. Kiwelekar** : **Computer Engineering**

This Committee will submit a Report on Framing of New Syllabus and Implementation model to the Vice-Chancellor by August 31, 2019.

3.3 It is proposed to introduce Add-on-Course and an Elective at Third year & Final Year by the Department of Information & Technology (IT)

It was proposed to introduce Add-on-Course on ‘Database Programming’ designed by IBM, Pune, by the Board of Studies (IT) and Course credits to reflect on the grade sheet as additional credits.

Resolution: *The AC appreciated the efforts of IT Department and approved the same. It was also suggested all the Disciplines should encourage introduction of such Add-on-Courses in areas of future importance for the benefit of the students of the University.*

Item No. 4: Examination results analysis of Academic Year 2018-19

Dr. H S Joshi presented the status of results for both Odd and Even Semester examinations for the AY 2018-19.

Resolution: *The AC resolved to approve the same.*

The AC appreciated the efforts put up by all in accelerating the new evaluation process brought into effect, and timely declaration of all Regular Examination Results.

The Vice-Chancellor extended a Special Appreciation to Godavari College of Engineering, Jalagon, for the highest contribution towards on-line evaluation of answer books at University level, and Department of Mathematics – DBATU at Campus level.

Item No. 5: Replacement of Relative Grading with Absolute Grading

5.1 Replacement of Relative Grading with Absolute Grading

At present, for B.Tech program, the University has adopted relative grading system. It is proposed to replace relative grading with absolute grading system as given below.

It is also proposed that the Award of Class be revised as follows:

At present, the Class is awarded based on the CGPA for all eight semesters of B.Tech. Program for

CGPA < 5.50	Pass Class
$5.5 \leq \text{CGPA} < 6.00$	Second Class
$6.0 \leq \text{CGPA} < 7.50$	First Class
$\text{CGPA} \geq 7.50$	Distinction

CGPA will be converted into percentage of marks by multiplying CGPA with a factor of 10.0.

CGPA: Cumulative Grade Point Average based on all Eight Semesters.

The above changes in Grading and award of Class will be implemented from the Academic Year 2019-20.

Resolution: *The AC after due deliberations resolved to approve the replacement of the present Relative Grading system by Grading based on Absolute Marks as indicated above, to be effective from AY 2019-20, for all U G and P G students of University from First year to Final Year*

5.2: Separate head of Passing for Architecture

Issues related to mode of Evaluation, Credit System, Pass / Fail and Progression Mechanism etc., for B. Arch program as per requirements of COA were discussed, as per details attached in **Annexure-A**.

Resolution: *The AC resolved to approve the minimum marks requirement as proposed for Continuous Evaluation, Mid-Semester and End-Semester Examinations for B.Architecture.*

5.3: Promotion rules for Pharm D Program

With reference to Point No. 15 of Regulation for Pharm D as published in THE GAZETTE OF INDIA, No.19, PART III, SECTION 4] dated May 10, 2008, Eligibility for promotion to next year:

1. All students who have appeared for all the subjects and passed the First Year annual examination are eligible for promotion to the Second Year and, so on.
2. Failure in more than two subjects shall debar him or her from promotion to the next year classes.

It is proposed that considering the meaning of the sentence “failure in more than two subjects shall debar him or her from promotion to the next year classes”, the students failing in One or Two subjects in a year of study, the student should be allowed to keep term (ATKT) and be promoted to next year of study.

Resolution: *The AC resolved to approve the proposal stating that “Failure in more than two subjects shall debar the student from promotion to the next year”.*

5.4: Equivalence/backlog subjects to be given while changing of course in II year Diploma program

Principal IoPE presented the case of offering change of program for the students after successful completion of First Year. As per DTE guidelines, these students have to clear some equivalence/backlog subjects as a requirement for the new program. Proposal is made for the approval of Equivalence Subjects (Annexure-B-1).

Resolution: *The AC resolved to approve the new requirements as proposed in Annexure-C.*

Item No. 6: Minimum passing marks at the B.Tech End Semester Examinations - Carrying 60% marks

At present, for B.Tech Program of the University, a total of 100 marks for each theory course are distributed as follows;

Minimum marks required to clear the course is (from items 1+2+3) 40 marks out of a total of 100. There is no separate minimum marks requirement for Items 1, 2 and 3 separately.

The students who have scored internal marks of 35 or more from MSE, CA1 and CA2 are clearing the course even if they get zero marks in End-Semester examination diluting significance of End Semester examination.

Resolution: *After due discussions, the Academic Council resolved to make it mandatory for every student of B.Tech to score a minimum of 20 marks out of 60 marks from End-Semester Examination, to clear the course in addition to scoring overall 40% of marks out of 100, to maintain the Academic Standards of the University. This Resolution shall be implemented from the batch entering the First Year B.Tech from the academic year 2019-20, onwards.*

Item No. 7: Minimum credits for “Carry On - Promotion to Next Year”

At present, for B.Tech program, every student has to clear a minimum no. of credits as follows to be promoted to higher class:

- i) 60% of the total credits prescribed for first year program for claiming promotion to second year B.Tech Program.
- ii) For claiming promotion to third year, every student has to clear all credits of first year and 60% of the total credits of second year B.Tech.
- iii) For claiming promotion to final year, every student has to clear all credits of second year and 60% of the total credits of third year B.Tech.

Resolution: *After due deliberations, it was Resolved to modify the above Promotion Rules for the students of B.Tech Course, from the current academic year, effective for all the students of I, II, III & IV year as follows:*

A) For students admitted directly :

1. *Students should clear 60% of the total credits prescribed for First Year B.Tech program for claiming promotion to second year.*
2. *For claiming promotion to Third year, every student should clear 80% of the total credits of I and II Year B.Tech considered together.*
3. *For claiming promotion to Fourth year, every student should clear 86% of total credits of I, II and III Year B.Tech considered together.*

B) For students admitted Laterly :

1. *Students should clear 60% of the total credits prescribed for Second Year B.Tech program for claiming promotion to III year.*
1. *Students should clear 80% of the total credits prescribed for II & III year B.Tech program considered together for claiming promotion to IV year.*

As per the Resolution made above, and in view of the Urgency of the matter, as it is related to promotion of students, and as admissions are already on, this resolution should be implemented for all the students of the University immediately.

Similarly for Diploma students at present to be able to progress for higher classes:

A student must clear minimum 45 credits (i.e. 75% of total credits) to be eligible for the admission to the next year and he/she must clear all the 60 credits of first year and minimum 45 credits of second year to be eligible for admission to third year.

Resolution: After due deliberations, the AC Resolved to modify the above Promotion Rules for the students of Diploma Course, from the current academic year, effective for all the students of I & II, year as follows:

(A) For students admitted Directly :

1. Students should clear 60% of the total credits prescribed for First Year Diploma program for claiming promotion to second year.
2. For claiming promotion to Third year, every student should clear 80% of the total credits of I and II Year considered together.

(B) For students admitted Laterly :

3. Students should clear 60% of the total credits prescribed for II Year program for claiming promotion to III year.

The Student failing in regular and/or subsequent remedial examination or in term work and secured either “FF”, “FR” or “XX” will be allowed to re-register for those failed subjects or term work during corresponding semester (Annexure-B-2).

4. **Alternative Arrangement for Mid-Semester and End-Semester Examinations for the students participating & representing the University in NCC, NSS or Sports at Inter-University, National Or International Level competitions:**

Alternative Mid-Semester and End-Semester Examinations will be conducted for the Students representing the University in NCC, NSS or Sports at Inter-University, National Or International Level competitions, in case the dates of such competitions coincide with the dates of said examinations. The student needs to produce certificate duly certified by competent authority to the Controller of Examinations to avail this facility.

Item No. 8: To approve the Equivalence of subjects from the Faculty of Engineering and Technology, Architecture, Pharmacy, Hotel Management and Catering Technology. (for Migrated Students)

Deans of different Faculties proposed Equivalent Subjects to facilitate migration of students from other Universities to DBATU:

Resolution: The Academic Council resolved to approve the adoption of the same as shown in Annexures-C, D & E.

This Resolution will come into force for all the Ph.D Scholars – Existing and New from AY 2019-20. From now onwards no Ph.D Thesis shall be accepted for Examination, without fulfilling the above criteria.

Resolution: *After due deliberations, it was resolved to permit students with BE/B.Tech Degree to do M.Tech in any relevant branch of Engineering / Technology encouraging cross migration of students for specialization.*

Concerned BOS will recommend the eligible branches for such admissions in their respective disciplines. All the BOS will prepare list of other branches eligible to do M.Tech in their branch of engineering to the Vice-Chancellor by Sept. 15, 2019.

3. B.Tech Level - Majors and Minors:

It was proposed to introduce the concept of Major and Minors at B.Tech level, to enhance learning skills of students, acquisition of additional knowledge in domains other than the discipline being pursued by the student, to make the students better employable with additional knowledge and encourage students to pursue cross-discipline research.

a. Majors

It is proposed to enhance the learning levels of students and acquisition of knowledge by the students from other domains.

- It is proposed to offer B.Tech (Honours) Degree to the students in a given discipline by offering Five Additional Advanced Courses of Four Credits each amounting to 20 Credits, from V Semester onwards.
Students with a Minimum CGPA of 8 will be eligible for the same, which they have to register from V Semester onwards.
Student complying with this norm will be awarded B.Tech (Honours) Degree.

b. Minors

It is proposed to offer Five Courses of 4 Credits each from B.Tech V Semester to the students, amounting to 20 Credits, from every Discipline. Students from a given Discipline can opt for these additional courses offered by any other Discipline of their interest.

Students earning these additional 20 Credits will be awarded with B.Tech Degree in -----
- Engineering with Minor in ----- Engineering. Students with a Minimum CGPA of 8 will be eligible for the same.

(For eg: B. Tech in Civil Engineering with Minor in Computer Engineering)

Resolution: It was resolved to adopt the new system of offering Majors and Minors from the AY 2020-21.

The Committee will submit a Report on the List of Courses to be offered (Majors & Minors) along with Syllabus by September 15, 2019, to the Vice-Chancellor / Chairman of Academic Council. The Committee will interact with respective BOS for forming the syllabus for different courses.

4. New B.Tech Syllabi Structure:

It is proposed to modify the Syllabi for the B.Tech from AY 2020-21, keeping in view the New National Education Policy 2019, to facilitate students acquire additional knowledge in other domains than being pursued, more inputs from Humanities, involvement of students in activities etc.

The following structure is proposed for the B.Tech Curriculum:

- A. Percentage of Basic Sciences : 15%
- B. Percentage of Core Subjects, Including Departmental Electives : 45%
- C. Percentage of Open Electives, making students to opt from : 20%
Across various disciplines
[Every Department should offer Open Electives from IV Semester]
- D. Percentage of subjects from Humanities Domain : 20%

Resolution: After due discussions it was resolved to implement the new scheme of B.Tech Syllabi from AY 2020-21. The following Committee is constituted to formulate the subjects/Courses with Uniform credits across all disciplines (Semester wise structure) and submit a Report to the Vice-Chancellor by September 15, 2019:
